

OFFICIAL RULES – CHAYANNE SWEEPSTAKES

1. Eligibility. The Chayanne Sweepstakes (the “Sweepstakes”) is open only to legal residents of the fifty (50) United States or the District of Columbia, who are at least the age of majority in their state of residence (which is eighteen (18) in most states but is nineteen (19) in Alabama and Nebraska and twenty-one (21) in Mississippi) at the time of entry. Employees, officers and directors (and each of their immediate family members (i.e., parents, legal guardians, children, grandparents, grandchildren, spouses or siblings and their respective spouses) and those living in their same households, whether or not legally related) of Cardenas Marketing Network, LLC (collectively, “Sponsor”) and each of their respective parents, affiliates, subsidiaries and advertising and promotion agencies are not eligible to enter or win the Sweepstakes. 2. Entry Periods. The Sweepstakes entry period begins on or about August 21, 2026, 9:00 P.M. and ends on August 26, 2026, 11:59 P.M. PT (“Pacific Time”), unless otherwise modified in Sponsor’s discretion, subject to applicable law (the “Sweepstakes Period”).

3. How to Enter. You may enter the Sweepstakes by submitting *one (1) entry* via the *Online Method of Entry*, or the *Free Alternative Method of Entry* set forth below.

- a. *Online Method of Entry.* To enter the Sweepstakes: 1) upload a video of yourself dancing using your personal Instagram account at any time during the Entry Period, and 2) your post must tag @cmnevents and @Chayanne and include the hashtag #BailandoconChayanne; posts that do not include all required tags and the hashtag will not constitute valid entries. Limit of *one (1) entry* per person. Submitting more than one entry per person may result in disqualification of such entries, at Sponsor’s sole discretion. Entrants are not being judged on their dancing ability, creativity, performance quality, production value, popularity, or any other subjective criteria. The content of an Entrant’s video will not increase or decrease the Entrant’s chances of winning. Entrant’s Instagram account must be public at the time of entry and through winner verification in order for Sponsor to review the entry and contact the Entrant if selected as a potential winner. All eligible entries will receive an equal opportunity to be selected in the random drawing. For the Online Method of Entry, Instagram serves as the platform through which eligible entries are submitted. An eligible entry will be deemed received when the Entrant’s qualifying Instagram post includes all required tags and hashtags and is publically viewable by Sponsor during the Sweepstakes Period. Sponsor is not responsible for entries that cannot be viewed due to privacy settings, account restrictions, platform failures, deletion of posts, or improper use of required tags or hashtags. Sponsor is not responsible for entries that are not captured due to an Entrant’s failure to properly use the required hashtags, tags, account settings, privacy settings, or platform functionality. If an Entrant accesses the Sweepstakes on Entrant’s mobile device, the Entrant’s wireless service provider may charge Entrant for applicable message and data charges. Entrants should consult their wireless service provider regarding its pricing plans prior to participating via a mobile device.
- b. *Free Alternative Method of Entry.* To enter the Sweepstakes without submitting through Instagram as set forth in Section 3(a), please handprint your: (i) first and last name, (ii) email address, (iii) mailing address on a postcard approximately three and a half by five inches (3.5" x 5") in size, and (iv) the name of the Sweepstakes, and mail it to: Cardenas Marketing Network, LLC, 1459 W. Mail-in entries will be included in the random drawing and have equal odds of winning as online entries.

Proof of submission (including proof of mailing) does not constitute proof of receipt. Those who submit more than the number of entries as set forth above, or do not follow all of the instructions, provide the required information in their entry form, or abide by these Official Rules or other instructions of or provided by Sponsor may be disqualified at Sponsor's sole and absolute discretion. All entries that are late, illegible, incomplete, damaged, destroyed, forged or otherwise not in compliance with the Official Rules may be disqualified from the Sweepstakes at Sponsor's sole and absolute discretion. Entries generated by script, macro or other automated means and entries by any means which subvert the entry process are void. All entries become the property of Sponsor and will not be acknowledged or returned.

In the event of a dispute as to the identity of any Entrant who submits an entry, the authorized "account holder" of the Instagram account used to submit entry shall be deemed the Entrant (or the email that was provided on a postcard entry), but only if such person is otherwise eligible. Entrants may be required to show proof of being the registered account holder. If a dispute cannot be resolved to the Sponsor's satisfaction, the entry will be deemed ineligible. Sponsor and affiliated entities are not responsible for lost, misdirected, misplaced, stolen, tampered with, deleted, or invalid entries. Assurance of delivery of entries is the sole responsibility of the Entrant.

4. Representations and Warranties. Each Entrant represents and warrants that he or she has read, understands and will follow the Official Rules. Each Entrant further represents and warrants that he or she has the right to agree to and fully perform consistent with these Official Rules and the consent of no third parties are required to grant the rights hereunder. Entrant further acknowledges and agrees that he/she has not previously granted, assigned or otherwise hypothecated his/her submission to any other third party. Further, each Entrant represents and warrants that Sponsor's use of any submission shall not violate an agreement to which such Entrant has signed.

5. Indemnity. Entrants agree to defend, indemnify and hold harmless the Released Parties from and against all the liabilities, claims, damages and expenses (including reasonable attorney's fees and costs) arising out of any breach of any representation, warranty or covenant made by such Entrant in connection with his or her acceptance of these Official Rules or Sweepstakes activities.

6. Determining the Winner. Sponsor will randomly select *one (1) Entrant* as the winner(s) from a random drawing from all eligible entries received during the Sweepstakes Period (each, a "Winner"). Any Entrant selected as Winner shall be referred to as a "Potential Winner" until such time as it can be verified by the Sponsor or its designee that the Potential Winner has complied with these Official Rules and met the terms and conditions set forth herein. Once verified, the Potential Winner shall be declared the Winner. Odds of winning depend on the number of entries received.

7. Winner Notification. Each Potential Winner will be notified by Instagram direct message sent to the Instagram account used to enter the Sweepstakes, mail, and/or e-mail (as selected by Sponsor) on or about August 27, 2026, unless extended by Sponsor. The Sponsor is not responsible for false, incorrect, changed, incomplete or illegible contact information. Notification is deemed to have occurred immediately upon sending of an Instagram direct message or e-mail, one (1) day after sending via a delivery service or two (2) days after mailing. To be confirmed as a winner, each Potential Winner must respond to the notification message and provide his or her full name, mailing address, e-mail address, telephone number, and any other information reasonably requested by Sponsor within *twenty-four (24) hours* of the date the notification is sent. Entrants are solely responsible for monitoring their Instagram accounts, including message requests, for notification. 11. Suspension / Modification / Termination. In the event Sponsor is prevented from continuing with the Sweepstakes or the Event is cancelled by any event beyond its reasonable control, including, but not limited to, fire, flood, epidemic, earthquake, explosion, labor dispute or strike, act of God or public enemy, communications or equipment failure, utility or service interruptions, riot or civil disturbance, terrorist threat or activity, war (declared or undeclared), interference with the Sweepstakes by any party, or any federal state or local government law, order, or regulation, order of any court or jurisdiction, or other cause not reasonably within Sponsor's control (each a "Force Majeure" event or occurrence) Sponsor shall have the right to modify, suspend or terminate the Sweepstakes. 13. Disputes / Arbitration / No Class Relief.
